

ST JOHN'S UNITED CHURCH ANNUAL CONGREGATIONAL MEETING MINUTES SUNDAY FEBRUARY 24TH 2019

After a lunch provided by the women of the church, Krista Belrose, chair, called the meeting to order at 11.40am. There were 51 adults in attendance.

Rev Meg opened with a prayer and a children's time.

It was moved by Liz McKnight and seconded by Susan Elliott "That adherents be granted voting privileges on Temporal (non-spiritual) matters only." Carried.

The Agenda with the addition of "the piano motion" under new business was moved by Ken French and seconded by Dick Marshall. Carried.

Marlene Tinney moved "that the minutes of the February 25th 2018 Congregational Meeting be approved as circulated or corrected" seconded by Sandy Coe. Carried.

In Memorial by Rev Meg.

Team Reports were reviewed. It was confirmed that the expenses in the Sunday School report, includes VBS expenses. Ross also confirmed that there is a loan of \$14000 from the General Fund outstanding on the Solar Project. The initial expense was roughly \$70,000. Moved by Debbie Laycock and seconded by Dick Marshall "that we approve the Team and Group Reports as presented in the 2018 Annual Report" Unanimously carried.

Moved by Kathleen Kenney and seconded by Linda Bye "that we approve the 2018 Financial Statements as presented". Unanimously carried.

Ross presented the budget. After clarification of staff salary reductions, custodian as no longer does snow removal and a new administrator, it was moved by Don Kennedy and seconded by Debbie Laycock "that we approve the 2019 budget recommendation as presented by the Property and Finance Team on behalf of the Council Executive" Unanimously carried.

- c) No nominations from the floor.
- **d)** Karen Parnell gave a presentation about the purchase of a used grand piano. After a short discussion it was moved by Karen and seconded by Doreen Turner "to purchase a Yamaha GT2 Piano and issue an initial cheque of \$2000". Carried unanimously.

Minister's Report for 2019 Rev Meg Jordan

Worship and fellowship are at the heart of our life here at St. John's United Church. Our life of prayer, music, learning, celebrations of significant moments, care about those who suffer, and concern about seeking better ways to follow Jesus in our desperate world and finding deeper and more truthful ways to express our love for God is fundamental to who we are.. Our children are growing up in a world of constant movement where everything is changing including our images of God. As Christians we must work hard to find new ways to speak of God and worship God in this changing world. We all grew up with the idea that God never changes. Most of us make the mistake of thinking that means that what we were taught about God never changes. Nothing could be further from the truth and most of us come face to face with this when we suffer and when bad things happen. Often my pastoral care ministry away from the church building has to do with accompanying those whose lives have been or are being turned upside down by misfortune. At the end of this year my own life was turned upside down when I fell down some stairs and mercifully, only injured my left arm and hand. As I write this report I am very aware of being a wounded "leader" very much in need of healing and understanding.

The United Church across Canada has had to face the realities of our changing world. We have just gone through the first year of a new organizational plan. We have lost our presbyteries and now have only three levels of governance—communities of faith, regional councils, and a considerably reduced national Council. All of these changes were happening at a time when many important decisions were being made at St. John's including my own call to be your minister. Our allocation to the region of Western Ontario Waterways was unfortunately the last thing on our radar and we find ourselves in relationship with areas of the province with whom we share little. The reality is that most of our connections and relationships are with organizations and institutions in Barrie, Midland, and Orillia. After much discussion at council we requested to be reallocated to shining waters region. This request was denied and through conversations with colleagues I have been given to understand that we should wait until things settle before asking for such a change. In the meantime Audrey Archer and myself attended the meeting of the Shining Waters Region at the end of May which was held at the Georgian College in Barrie. I made a presentation on behalf of the North Simcoe Rural Cluster of which St John's has become an active member. Ironically, after all this, we have been working closely with WOW for most of the year due to the sale of the manse. Council will now have to decide whether we will pursue a change of regional membership or not.

I am your minister of worship, sacraments and pastoral care and work involved with this takes up most of my time. Highlights for me in 2019 have been the Good Friday service with the drama involving Greg Parnell as Barabbas and Kevin Cullen as Jesus, PA days as an outreach program for local families (many non-church), our first Health and Wellness Day with booths and speakers, the Canadian Foodgrains concert, monthly movie nights which have moved to the last Tuesday of the month and last but not least, ongoing work with the Accessibility Team. Beyond the walls of the church I have been very involved with issues concerning our local watershed, and the Simcoe County Honduras Monitor Group concerning justice for Edwin Espinal. At recent meetings of council I have expressed my concern about St. John's finances and the need for the development of a membership and stewardship team. You'll be hearing lots more about that in the year to come.

I remain very happy to be your minister. You are a wonderful community to serve. I enjoy and appreciate working with Bob and Karen. Please feel free to talk with me at any time about your concerns, and hopes and dreams. I know you have them. Lovingly, Rev Meg

2019 Music Director's Report

The biggest musical highlight in 2019 for St. John's would have to be the arrival of our 'new' Yamaha grand on Mon Mar 25. Since then, service music seems to sparkle a little brighter, particularly when Karen Parnell takes over on the piano and I am able to move to the organ. Special thanks regarding the speedy completion of the project should include Karen who partnered with me as an ad hoc "piano search" committee, Beth Truax and the Worship committee, Ross Langman and the Finance Committee, and Jerome.

Three other music events jump out as particularly notable from 2019: the two "You Asked for it" concerts on Mar 3 and Oct 6 and the Canadian Food Grain Cantata presented Nov 24. I think most would agree we should do those again. Regarding the "You Asked for It" concerts, it was so inspiring to see each having large attendances and wide ranges of performers. The Elmvale area not only has a lot of talent, St. John's in particular has a great emcee in Rick Mueller to bring it all together. As to the Canadian Food Grains cantata, the effort seemed worth it in multiple ways: attendance and offering was high, the music was surprising fun to learn and perform, and the feedback was very appreciative (e.g., "I would come back tomorrow and listen to that again").

Continued appreciation and thanks to the Praise Team for again providing music leadership at ten services in 2019. And similar appreciation and thanks to Karen Parnell, not only for playing piano on Sundays when she is there, but also for her music direction when requested (most particularly, her fine direction of Double Treble).

Below is a list of other special church music moments from 2019, ordered by date:

- After much rehearsal, the choir's initial performance of Africa on Jan 20 was polished and greatly appreciated (Thanks Will, for the steady beat!)
- Later that week, many St. John's choir members joined with St. Paul's Midland choir at the funeral for former music director Phyllis McCullough on Jan 25 in Midland. Karen Parnell was the soloist at the funeral.
- Rev. Meg, the Choir and Double Treble once again led a Vesper Service on Thu Feb 21 for the residents and staff of Sara Vista.
- As we enjoyably do every year, our choir joined with other Elmvale choristers to present the cantata *Hallelujah*, *What a Savior* on Palm Sunday evening Apr 14.
- With a lot of sadness, the choir (and Double Treble) performed at the Presbyterian farewell event for Rev. Paul Sakasov on Jul 13. (Rev. Paul appeared particularly touched that our choir performed an arrangement of his original piece *Abba Father*).
- Also now part of our yearly routine, the choir (and Double Treble) participated at Gospel in the Park the evening of Sun Jul 28.
- Meanwhile over the summer, special music for services typically was provided by guest musicians, including for the first time, Rev. Meg herself (thanks for that bit of multi-tasking, Rev. Meg).
- For the first time over the summer, Double Treble continued practicing regularly specifically to provide music leadership at the annual name-day mass at the Martyrs' Shrine in Midland (Sep 28). Service attendees seemed very appreciative and immediately talked about a DT return in Sep 2020. I was particularly honored on the occasion that DT performed my *Nunc Dimittis*.

- We in the choir was very excited in early Oct to learn Night of the Father's Love had been selected to do in Advent at the community cantata service... Night is definitely one of our favorites! Thus, rehearsals were a joyful end to Thursdays through much of the fall. Final performance took place Sun evening Dec 15 at the Presbyterian church and was very well received.
- With mixed emotions, our annual Christmas Lessons and Carol Service took place on Sun Dec 22. Sadly, we were missing Rev. Meg due to her fall earlier in that week. On the other hand, Rev. Meg had the service prepared well in advance and everyone came together to once again provide an extraordinary service of calm re-centering just before Christmas.
